Question: One of our Debtor has made us payment from Punjab after deduction of 13 % W.H. S.Tax from our Service bills. Kindly guide us have they correctly deducted 13 % Sales Tax (Total S.T amount) or not. If correct, can we adjust 13 % W.H. Sales tax against above mentioned bills in our S.R.B return to reduce our S.Tax liability?

Answer: If services are provided in Karachi then the person from Punjab was not liable to deduct tax on it. If he has place of business in Sindh then he is a withholding agent for SRB. If he deposited tax with SRB then you can claim adjustment of withholding tax. If he deposited tax with PRA, it is his mistake and not yours, you may take adjustment of it.

Question: We are registered under Sindh Sales Tax on Services which we pay at the rate of 13% on services provided within the province. We however understand that no SST is applicable on services that are provided in other provinces of the country, i.e. KPK, Punjab or Baluchistan and we are required to submit a zero rating invoice to our client against provision of services in areas outside Sindh Province. Additionally, we also understand that the client in this respect is not supposed to withhold and subsequently deduct from our invoice any amount in the name of Sales Tax on Services from our invoice and also let us know if we are required to get registered under sales tax in other provinces as well and subsequently pay Sales Tax on Services under their rules (i.e. as per applicable rate) in order to provide services therein.

Answer: 1. There is no concept of zero rating in inter province services. 2. If you are providing services in difference provinces, then you'll have to get registration with all the provinces and issue invoices accordingly as per applicable rate of the relevant province. Then submit monthly returns of all the provinces separately.

Question: Dear Sir, being Withholding Agent under PRA, should we have to issue Wihholding Tax Certificate to our Service Providers likewise we issue in Federal. if yes, what is the format of Certificate?

Answer: Yes. Format is available in Form B of Punjab Sales Tax on Services (Withholding) Rules, 2015.
