Question: We are the Auto Mobile Dealer of Indus Motor Company. We sale new cars & giving Services (Workshop). We are registered with SRB & paying monthly sales tax on services. Are we supposed to pay/contribute under the Sindh Workers Welfare Fund Act -2014

Answer: Sindh Workers Welfare Fund Act, 2014 is only applicable on Industrial establishments as defined in Section 2(g) of Sindh Workers Welfare Fund Act, 2014 and auto workshop does not fall in this category, because in sub-clause (i) the term workshop is used but in different meaning.

Question: I want to ask that if wife and husband both are taxpayers and file their returns 1 How will they show the expense in wealth statement 2 Will both of them have to show the asset of each other in wealth statement.

Answer:

- 1. Total expenses will be shown in the return and then each taxpayer will declared the contribution in Expenses made by other taxpayer (Family Members). Code: 7088
- 2. No. both will declare their own assets.

Question: If the quotations are invited through normal procedure against sale of material not through auction then is there section 236-A applicable or not please

Answer: Yes, this falls under section 236A, this may be called silent auction.
